Kombinirana mobilnost (blended mobility):

Kombinacija fizičke mobilnosti i virtualne komponente koja omogućuje suradničko učenje / timski rad putem interneta.

Uz fizičku mobilnost sve aktivnosti mobilnosti osoblja i učenika mogu se kombinirati s virtualnim aktivnostima.

Zeleno putovanje - na kojem se veći dio puta (više od polovice povratnog puta) koriste prijevozna sredstva s niskom razinom emisija, kao što su: autobus, vlak, bicikl ili zajedničko putovanje jednim vozilom.

Sudionici koji se odluče za zeleno putovanje mogu, povrh uobičajena 2 dana potpore za dane puta, dobiti najviše 4 dodatna dana potpore za dane puta, odnosno ukupno najviše 6 dana. Naravno, samim korištenjem opcije zelenog putovanja nije moguće automatski dodijeliti sve dodatne dane puta; ti dani trebaju biti dodijeljeni sukladno putnoj udaljenosti i načinu putovanja, o čemu procjenu donosi korisnik. Dodatni dani puta bit će revidirani u fazi analize završnog izvješća.
